

# Privacy Policy

## Introduction

We are the Reformed Church in Hungary (RCH), and we maintain our online services in accordance with European and Hungarian information privacy laws. We have had long-standing policies and procedures to protect your personal data in compliance with GDPR.

Our privacy policy will help you understand what information we collect at **Mecénátus app**, how RCH uses it, and what choices you have. RCH built the Mecénátus app as a free app. This SERVICE is provided by RCH at no cost and is intended for use as is. If you choose to use our Service, then you agree to the collection and use of information in relation with this policy. The Personal Information that we collect are used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy. The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, which is accessible in our website, unless otherwise defined in this Privacy Policy.

## Information Collection and Use

For a better experience while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to users name, email address, gender, location, pictures. The information that we request will be retained by us and used as described in this privacy policy.

The app does use third party services that may collect information used to identify you.

## Cookies

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your devices's internal memory.

This Service does not uses these "cookies" explicitly. However, the app may use third party code and libraries that use "cookies" to collection information and to improve their services. You have the option to either accept or refuse these cookies, and know when a cookie is being sent to your device. If you choose to refuse our cookies, you may not be able to use some portions of this Service.

## Location Information

Some of the services may use location information transmitted from users' mobile phones. We only use this information within the scope necessary for the designated service.

## **Device Information**

We collect information from your device in some cases. The information will be utilized for the provision of better service and to prevent fraudulent acts. Additionally, such information will not include that which will identify the individual user.

## **Service Providers**

We may employ third-party companies and individuals due to the following reasons:

To facilitate our Service;  
To provide the Service on our behalf;  
To perform Service-related services; or  
To assist us in analyzing how our Service is used.

We want to inform users of this Service that these third parties have access to your Personal Information. The reason is to perform the tasks assigned to them on our behalf. However, they are obligated not to disclose or use the information for any other purpose.

## **Security**

We value your trust in providing us your Personal Information, thus we are striving to use commercially acceptable means of protecting it. But remember that no method of transmission over the internet, or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security.

## **Children's Privacy**

With the data of children under age 16, we process the data with permission from their parent or guardian. Children under age 16 can only register into the Mecénátus app with the permission of their parent or guardian. During the registration process children under age 16 should provide the e-mail adress of their parent or guardian for approval..
